# **August Elections**

The election season is upon us. It is important that all citizens eligible to vote register to vote. Registration is only the first step in the process. Once you have registered to vote you should learn about the candidates and issues, and of course you should vote. In July the NUCA Florida PAC met and voted to endorse a slate of over two dozen candidates, of both political parties, and contributed nearly \$25,000 for the candidates that have a proven track record on issues important to our industry. The vetting process depends on the recommendations of Kari at Wilson and Associates and the local NUCA chapter where the candidate resides and serves.

In addition to the elections related to the Florida Senate and House of Representatives, in Duval County there are several races in which the candidates have supported our organization or have reached out and attended a meeting to introduce themselves to our membership. Your vote should be a thoughtful and personal decision and this article is only intended to be informational. In many of the contested races there may be more than one candidate that is an outstanding candidate in her/his own right.

Former Representative **Charles McBurney** is a candidate for Circuit Court Judge for the 4<sup>th</sup> Judicial Circuit. Charles has attended numerous NUCA Meetings, always made himself available to meet with the membership in Jacksonville and Tallahassee, sponsored legislation at the request of NUCA, and was the recipient of the second Don Davis Award by NUCA for outstanding public servant.

Former Representative Lake Ray, III is a candidate for Duval County Tax Collector. Lake most recently attended our Scholarship Award meeting and has met with the NUCA membership numerous times during his eight years in the Florida House of Representatives and supported legislation that was important to NUCA. Lake was the third recipient of the Don Davis Award. The Don Davis Award has only been awarded three times in the past ten years and the only other recipient of the award is former speaker of the House Will Weatherford.

Joseph Hogan attended a NUCA function and expressed support for NUCA initiatives and is a candidate for District 15 House of Representatives.

In Group 3 County Court Judge, **Michael Bateh** and in Group 8 **Kimberly Sadler** have attended NUCA meetings.

There are other contested elections including School Board and Soil and Water Board for your consideration. In November a general election will be held and information on those races will be addressed in months to come. Early voting begins on August 13. # **GAME DAY**

As with anything, there are hazards to consider and some precautions that we might want to take. It's a good idea to go on line and look at the do's and don'ts. All stadiums have rules to follow. Look at the floor plan for the seating in the stadium and parking areas to be see if you might be able to park nearest the gate where your seats are. Find the location where the closest restrooms and first aid services are located and be sure you know where the exits are. Crowds can be unpredictable. Know where security is and use the customer services when necessary. There are often family friendly sections that are available.

Do an effective job briefing with the family. Make sure you stay together and be sure that small children are always accompanied by an adult. Take a selfie of the group. If you get separated, security services can use the photo to find the missing member of the party. Be aware of the weather. Storms can disrupt the fun and send fans scrambling for cover. Many stadiums will not allow umbrellas so if the weather doesn't cooperate some rain gear might be advisable. Sun screen and protective clothing should be a consideration. It's always easier to wear more and take off what's not needed than to not have what you need when you need it. If you must take medication or carry items into the stadium, remember that you may have to have clear containers to carry those items.

Game day can be a fun experience for everyone if we remember the simple precautions we need to take to be sure everyone has a good time.
