#### Pre-suit Notice of Claim for Construction Defects is Considered an "Action" for Purposes of the Ten-Year Statute of Repose

A Florida appellate court in *Gindel, et al v. Centex, et al*, considered, for the first time, whether the mandatory pre-suit notice of defects in Chapter 558 qualifies as an "action" for the purposes of complying with the ten-year statute of repose for construction claims set forth in chapter 95.

The homeowners alleged that Centex and others had improperly constructed their townhomes and the contractor argued that the ten-year statute of repose for their claims had expired. In Florida, the ten-year statute of repose in chapter 95 applies to an "action founded on the design, planning, or construction of an improvement to real property... and must be commenced within 10 years after the date of actual possession by the owner, the date of issuance of a certificate of occupancy, the date of abandonment of construction if not completed, or the date of completion or termination of the contract..." Chapter 558 requires that any claimant asserting a construction defect claim must serve a written notice of claim on the contractor as a prerequisite to filing a lawsuit.

In *Gindel*, the homeowners filed a pre-suit notice of claim under chapter 558 before the tenyear statute of repose had expired, but did not file their construction defect lawsuit until approximately two months after the expiration of the ten-year statute of repose. Ultimately, the appellate court, in applying Supreme Court precedent, agreed with the homeowners that compliance with the pre-suit notice requirement in chapter 558 constituted an "action" for purposes of the ten-year statute of repose. Thus, the homeowners' action was considered timely filed under the statute of repose.

#### **SAFETY DIRECTOR'S GROUP HOLDS QUARTERLY MEETING**

#### **House Passes Critical Water Infrastructure Bill**

After months of negotiations, House and Senate leaders have reached an agreement on a Water Resources Development Act (WRDA). This legislation, S. 3021, the America's Water Infrastructure Act of 2018, includes numerous long-standing priorities for NUCA, and it is exciting that Congress has been able to come together to address our nation's infrastructure needs.

As *Political Insiders* are aware, the House's original WRDA bill was narrow in scope and limited largely to Army Corps of Engineer projects. The Senate's bill was much more expansive and included provisions to address drinking water and other water infrastructure in addition to Army Corps projects. Ultimately, the compromise between the two chambers includes many of the provisions from the Senate's version. The final provisions will invest in improvements in drinking water and other critical water infrastructure.

First and foremost, S. 3021 reauthorizes and modernizes the Drinking Water State Revolving Fund (DWSRF) program. This legislation provides nearly \$4.4 billion through fiscal year 2021, which is an increase over recently appropriated levels. Given that the authorization for this program previously expired in 2003, it is encouraging that Congress is finally addressing the issue after years of inaction.

Next, the legislation includes portions of the Securing Required Funding for Water Infrastructure Now (SRF WIN) Act, which has been a priority for NUCA and was one of the top items discussed with lawmakers during our Washington Summit. This legislation will help states access funding through the Water Infrastructure Finance and Innovation Act (WIFIA) program, and will provide low interest loans for critical projects with limited federal investment. Because of difficulties in getting the SRF WIN Act to conform to congressional budget scoring requirements, the provisions in the final WRDA bill have been scaled back from the original SRF WIN legislation. Regardless, this program provides another important tool in the toolbox for states and localities to address infrastructure needs.

Furthermore, the legislation also makes critical improvements to the WIFIA program. Specifically, S. 3021 removes the "pilot" designation for WIFIA and reauthorizes it through 2021. Through WIFIA, borrowers are able to access low interest loans with a long repayment period to finance Clean Water State Revolving Fund (CWSRF), DWSRF, and other water infrastructure projects. These loans can be used for large scale projects that might otherwise be difficult to finance through the SRF programs.

Now that the House has passed this legislation, it is up to the Senate to act. Senate leaders sound hopeful that they will be able to take up the bill before the midterm elections. We will continue to monitor this legislation and provide an update if and when it is signed into law.
