
The Law and Your Business

Florida's Indemnity Statute May Not Apply to Utility Work By Rebecca Ross, Regan Whelan Zebouni & Atwood. P.A.

On April 25, 2018, a Florida appellate court determined that Florida's Indemnity Statute section 725.06 for construction contracts did not apply to utility work. The *Blok Builders, LLC v. Katryniok* case involved a BellSouth project to improve its telecommunications services. As part of the Project, BellSouth contracted with Mastec to perform all work necessary to provide access to the underground lines located in neighborhood easements. Mastec then contracted with Blok to perform the excavation work. After Blok performed excavation work near a driveway in one of the neighborhoods, the driveway suddenly collapsed while a homeowner was walking on the driveway, which caused him to sustain serious injuries. The homeowner sued Blok, Mastec, and BellSouth for damages due to his injuries. Mastec and BellSouth crossclaimed against Blok for contractual indemnity.

The contract between Blok and Mastec contained a provision requiring Blok to indemnify Mastec for Mastec's own negligence. The contract also incorporated the terms of the prime contract between Mastec and BellSouth. Blok argued that the indemnity clause in the contract was invalid because it did not comply with Florida statute section 725.06, which requires a monetary limitation on indemnity clauses in construction contracts. The court, however, found that the statute did not apply to the contract because it was an excavation contract, which did not involve the construction, alteration, repair, or demolition of a building, structure, appurtenance, or appliance as specified in the statute. Similarly, the prime contract involved the laying and maintenance of utility lines; not the construction of a building or structure. Further, the court said that there were no terms in the Mastec contract that required Blok to indemnify BellSouth nor did the incorporation of the prime contract do so because the prime contract only required Mastec to indemnify BellSouth, not its subcontractors. Thus, depending on the scope of work, the contractual indemnity requirements in Florida statute section 725.06 may not apply to utility contracts.

SAFETY NEWS

Who Is The Real Safety Manager Where You Work?

Why would we ask such a question? Every company needs a person with a designation of Safety Manager but why? What are the specific duties of a Safety Manager? If we begin to list them we would probably start with compliance. Why do that? Because we need someone who should be familiar with and be a source of information about the safe way any job is being performed, or can access resources that are experts in the field, but, who is the real expert? Is it the person directly in charge of the duties of every member of a crew performing the work? Or is it someone who by education or experience has been given the title of Safety Manager and who may or may not be present at the time the work is being performed?

In my over 30 years of experience, I have found that the only time there is a very clear understanding of accountability for safety performance of employees and members of the crew is when the highest levels of supervision understand that the front line supervisor is ultimately responsible for the safety of those working directly under their supervision. Some companies tie the evaluation of front line manager's compensation to safety performance and, I know of some companies that put a 50% value on safety performance directly connected to bonus and raises. So why have a Safety Manager? There needs to be someone who can help train and educate supervisors on how to recognize hazards and to effectively manage people. Someone who is a resource of information in times when there needs to be a clear understanding of the safe way to perform our jobs. The Safety Manager's job is prevention. Establishing those leading indicators that will help companies find ways to heighten awareness and provide the tools supervisors need to fight the battle of preventing injuries and incidents.

For some less enlightened companies the Safety Manager is held responsible for compliance at every location and if there is an incident where safety procedures are not being followed, for example, an employee not wearing safety glasses has an eye injury. Who let him work without those safety glasses? In that case the Safety Manager is left managing the process of investigation, medical treatment, follow-up, etc. and his or her evaluation is based on trailing indicators of negative safety performance. So, we are again, left with the question, Who is the real Safety Manager on your jobsites? The answer is, in the best performing companies in safety, EVERYONE is a Safety Manager!
