The Law and Your Business – Lost Profits May be Recoverable in a Breach of Contract Claim against an Insurer

The *Manor House v. Citizens Property Ins. Corp.* case involved an insurance claim by the owner regarding nine apartment buildings that were significantly damaged by a hurricane. The owner presented its initial property damage claim to the insurer under the policy, which was paid. In April 2006, the owner's adjuster requested that the claim be reopened and a claim for \$10 million was presented to the insurer, Citizens. In response, Citizen's adjuster estimated the replacement cost value at approximately \$6.4 million. Citizens made additional partial payments to the owner in the amount of only \$345,192. The owner then demanded payment of the allegedly undisputed amount of \$6.4 million, which Citizens failed to pay.

The owner filed a lawsuit against Citizens for the undisputed amount and sought a Court Order compelling Citizens to participate in the policy provided appraisal process. In November 2009, the appraisal panel awarded the owner \$8.6 million in replacement cost value. In January 2010, Citizens paid an additional sum to the owner. The owner then pursued an action against Citizens for breach of contract for its failure to, among other things, pay the undisputed amount after estimate, honor the owner's demand for appraisal, and timely pay the appraisal award. The owner also sought to recover lost rental income due to the delay in making repairs at the apartment complex as a direct result of Citizens failure to adjust and pay the owner's claims in a timely manner.

The trial court granted Citizen's motion for partial summary judgment on the breach of contract claim regarding lost rental income because the insurance policy provided for property damage coverage, but it did not provide coverage for lost rents. The appellate court agreed, but noted that the trial court's ruling ignores the general principle that the injured party in a breach of contract action is entitled to recover monetary damages that will put it back in the same position that it would have been in had the other party not breached the contract. Thus, when an insurer breaches an insurance contract, the insured is entitled to recover consequential or lost profit damages provided the damages were in contemplation of the parties at the time of contract. Further, the appellate court held that in a claim for breach of an insurance contract, consequential damages may be recovered if they can be sufficiently proven. Thus, the appellate court reversed the trial court's partial summary judgment ruling and allowed the parties to litigate all issues related to the owner's claim for lost rent.

SAFETY NEWS

Skin Cancer Prevention

According to the CDC, 5 million people are treated for skin cancer in the US each year. Working outside exposes us to ultra violet rays even when it's cloudy. Over time, exposure to UV rays will permanently damage skin. Fortunately, most skin cancers can be prevented. Some steps that can be taken right away to prevent further damage.

Wear sunscreen. Always wear sunscreen when working outside. Water, concrete and sand all reflect and intensify UV rays. Use a sun protection factor (SPF) of 30 or higher.

Wear protective clothing. Loose fitting tightly woven long sleeve shirt and pants. Safety glasses should have a rating of 99% UV protection. Both clear and dark safety glasses can be purchased with UV protection.

What to look for. Check yourself out. Warning signs. A new or existing mole that has an irregular border or jagged edges. Moles bigger than a pencil eraser. A bump or patch that doesn't heal.

While skin cancer is more common in fair skinned people, it often goes unnoticed in darker skinned people until it's at a more serious stage. Frequent self-examination and a visit with a dermatologist can help prevent more serious stages of skin cancer.

An interesting statistic is that melanoma is one of the most common forms of cancer in people younger than 30 and the likelihood of developing melanoma doubles if you have had more than five sunburns.

We can't avoid sunlight in our line of work but we can take steps to minimize sun damaged skin. We can educate ourselves and we can recognize when we may need treatment. If we do discover symptoms that might be suspected skin cancer we can seek treatment and minimize the damage.
