#### Recent Appellate Ruling on Timely Recording of Liens a Win for Construction Lienors in Florida

In a win for construction lienors seeking to collect money due for their labor, services, and materials, through a construction lien under Florida's Construction Lien Law, Florida's First District Court of Appeal recently issued an important opinion on timely recording of construction liens by Clerks of Court in Florida in the case of *Pritchett Trucking, Inc. v. The Honorable Jody Phillips, as Clerk of Court for Duval County, Florida*.

The lienor, Pritchett Trucking, Inc. ("Pritchett Trucking") delivered its construction lien in the amount of \$118,288.83 and recording fee to the Duval County Clerk of Court ("the Clerk") within 90 days of its last furnishing of services to the project (on April 23, 2018) in accord with Section 713.08(5), Florida Statutes. Due to no fault of Pritchett Trucking, the Clerk failed to record the construction lien in the official records until seven (7) days later (on April 30, 2018), and two (2) business days **after** the statutory 90 day deadline for Pritchett's lien to be considered timely recorded, thus making Pritchett Trucking's construction lien untimely and unenforceable. These facts were not in dispute. When asked to correct the record, the Clerk said it was unable to do so.

Pritchett Trucking, represented by our firm Lippes and Bryan, P.A, sued the Duval County Clerk to require the Clerk to e-record the construction lien with the correct recording date of April 23, 2018 (the date the construction lien was delivered to the Clerk with the recording fee). At trial, Pritchett argued that under Florida law, the Clerk is required to record liens when presented and **upon** payment of the recording fee, with "upon" meaning "at the time of" or "immediately thereafter," not seven (7) days later. The Clerk argued that it couldn't correct the late recording due to software limitations and that even if it could, it should not be made to correct the record. The Duval County Circuit Court Judge rejected the Clerk's arguments and agreed with Pritchett Trucking, requiring the Clerk to record a copy of Pritchett's lien, together with the final judgment of the court, as a single document to confirm the date of delivery of the lien as the recording date, resulting in Pritchett's lien being timely.

Thereafter, the Clerk and Florida Association of Court Clerks appealed the Trial Court ruling to the First District Court of Appeal, in the first time this issue has been before the appellate courts in Florida. On October 6, 2021, the Florida First District Court of Appeal upheld the Trial Court ruling interpreting the statutes as requiring the Clerk to carry out its statutory duty of recording a lien when presented, upon payment. The First District Court of Appeal concluded its opinion as follows: "Here, there were seven days between when the duty to record arose and when the duty was carried out, which was not "upon payment," " and affirmed the Trial Court's Final Judgment. Hopefully, this recent ruling will make it easier for trial court judges to mandate clerks to re-record construction liens with the proper dates in cases like this one.

Practical tip for recording liens: for same day recording, especially with a looming deadline, physically take the lien to the Clerk's office for recording. If you mail it or electronically file it, you can expect days of delay in recording from the date of the Clerk's receipt of the lien and payment, with the time period being determined by a myriad of limitless undefined factors, such as the Clerk's available resources and employees, or lack thereof, or the effects of pandemics or hurricanes. And, if the Clerk untimely records your lien despite receiving it and payment before the recording deadline, you have a remedy under this appellate opinion and the applicable statutes cited in it.

#### NUCA Reacts To Delayed House Core Infrastructure Vote

The core infrastructure bill contains a historic amount of resources directed to water, broadband, and other infrastructure projects. The House's failure to promptly pass this bipartisan legislation places our member's projects, jobs, and future public works projects in jeopardy. NUCA CEO Doug Carlson stated, "House leadership has failed to recognize that clean water is not a political issue. Clean water and better infrastructure are not a Democratic or Republican talking point to be held as a hostage in extravagant political fights. Infrastructure is foremost an investment in every American community's well-being, economic growth, and the hope of a better future for millions of our nation's citizens." NUCA is urging our members to directly contact their lawmakers about this important bill via our Muster email advocacy link and support its passage without delay." #### Surface Transportation Reauthorization Gets 30-day Extension Through Oct. 31

Amidst the Democrats' fight over the two infrastructure bills, the House passed a 30-day extension of the FAST Act, the nation's surface transportation law, until Oct. 31. The chamber was unable to pass the core infrastructure bill, which contained the extension to the original Sept. 30 deadline. There was a one-day shutdown to the federal highway programs administered by USDOT, which has since ended but not before some 4,000 federal employees were temporarily furloughed. #### OHSA Hears From NUCA's Construction Safety Coalition On Employee Covid Mandate

The Biden Administration's pandemic response plan includes a mandate for all employers with 100 or more employees to receive a Covid vaccine or produce a weekly negative test before coming to work. In addition, federal contractors are mandated to receive the COVID vaccine, with no option for weekly testing. The Construction Industry Safety Coalition (CISC) and NUCA submitted on Sept. 27 our letter to OSHA's Administrator describing the "significant implications for the construction industry and for the construction workforce" if this mandate is implemented. OSHA is putting the mandate into effect through its Emergency Temporary Standard, which does not accept formal public comments. <u>Read the letter here</u>.

## SAFETY NEWS

### By Jeff Blomgren Safety Director at Petticoat-Schmitt Civil Contractors **Safety Training and Orientation. How important is it?**

In my 30 plus years of involvement in safety, I have learned one thing. If you want people to do the right thing, teach them what the right things are. In a labor market where we struggle to get qualified people to accomplish our contractual obligations we are faced with the reality that qualified people are very difficult to find. Also, our industry does not attract younger workers. The current education system lacks the emphasis on vocational training and are intent on qualifying students for a college education, many times, in useless degree disciplines. Many graduate and can't find employment in their chosen area.

Our industry pays well but the stigma of working in dirt only seems to appeal only to us and to farmers. We need to be able to reach a new market somehow. We need an infusion of candidates willing to work hard. Perhaps, with so many people leaving the job market in protest of government controls and mandates we may have an opportunity to provide a good living to people who want to make a change. If that happens, we need to advertise the opportunities and be prepared to help them understand the industry. That understanding comes with training. So many times we find that accidents and incidents are caused by lack of knowledge and understanding of the job tasks being performed. We rely on field training to take care of the education necessary to prepare a worker to do a job safely but that's not always the best policy.

There needs to be either a classroom environment or a similar process where the basics of the business and an outline of the expectations can be exchanged. Dialog can be established where new employees can learn the basics of what they might expect in the work environment. Explaining the simple things like PPE use and fundamentals of safe workmanship. Expectations for timeliness, accountability, attendance, skill development, communication channels, all can be accomplished by an effective orientation. The definition of "ORIENTATION" is "The direction someone is facing or the way someone tends to go.". Our obligation is not to expect or assume that training will occur. We need to be sure that it begins in an orderly and consistent process that includes the intent that we will start someone "facing the way they need to go" and be sure that the process is continued through the life of employment.


