The Law and Your Business

The Law and Your Business – Forum Selection Clauses *Christian Lake, Esq., Lindell Farson & Zebouni*

When things go wrong on a jobsite, it is important to know not only who your conflict is with, but also where the conflict must be litigated. While common sense would seem to dictate that a dispute arising in one state would be litigated within that state, that is not always the case. Florida law recognizes and enforces “forum selection” clauses within contracts, which require the parties to litigate a dispute in any state or city in the country. This can even be the case in instances where you have not signed a document containing the forum selection clause, as was the case in a recent Florida Court of Appeals decision, *W. Bay Plaza Condo Ass’n. v. Sika Corp.*

In that case, a condominium association sued a number of parties for allegedly defective repair work to the condominium building. Among those sued was the company that provided the sealant for repairs in the garage and provided the association with a warranty for that product. While the sealant company provided the association with the warranty, the condominium association never signed the warranty. However, the association’s sole basis for suing the sealant company was for breach of that warranty due to what it alleged was defective product.

The sealant company moved the trial court to dismiss the association’s complaint since the warranty contained a forum selection clause requiring that all litigation arising from the warranty be held in New Jersey exclusively. The association argued that the forum selection clause was not enforceable against the association, and the association was not required to litigate in New Jersey, since the association never signed the warranty.

However, both the trial court and the court of appeals ruled in the sealant company’s favor and dismissed the complaint in Florida due to the forum selection clause requiring that litigation be in New Jersey. The Court supported its position by stating that the association’s decision to sue for breach of warranty required that all the terms of the warranty be enforced, including the forum selection clause. The absence of the association’s signature on the warranty did not prevent the association from suing the sealant company if the product was defective, and the association was not permitted to cherry-pick which clauses it wished to be effective in a breach of warranty action.

Florida courts have long recognized the rights of parties to choose where litigation will take place in the event of a dispute. The association suing under the warranty necessarily triggered the forum selection clause and required the Florida courts to dismiss the complaint as against the sealant company. The association would be free to renew its action against the sealant company in New Jersey if it so desired.

If you have a contractual dispute, first make sure you are litigating in the right court. This can prevent wasted time and funds spent litigating in the wrong court in the event a forum selection clause requires litigation elsewhere. Additionally, having to travel across the country to litigate a dispute may influence whether litigating makes economic sense. FY22 Appropriations Bill Signed Into Law

The massive \$1.5 trillion FY2022 omnibus spending package to fund the federal government and the many Infrastructure Investment and Jobs Act (IIJA) program increases was sent last Friday to President Biden for his signature. NUCA is happy to report the president signed it into law on March 14, ending almost six months of speculation on final FY2022 funding levels for our programs.

The measure also includes year-over-year increases for many construction programs, and includes an additional \$500 million for broadband projects. The omnibus package also includes about \$650 million for specific water project earmarks, the first directed spending amendments from Congress in years.

The Senate passed the measure 68-31 on Mar. 10, with the House passing it with strong bipartisan support the day before. The federal government's fiscal year ends Sept. 30.

2022 H-2B Visas Increases Are Welcome, But More Are Needed

A recent change to the Federal government's temporary visa rules increasing the amount of available H-2B visas to be issued in 2022 is welcome news for America's utility construction companies, but it still falls short of what is needed. 13,500 of the new visas are being made available to returning past visa holders over the last three years. The additional 6,500 visas were reserved for citizens from Haiti, Honduras, El Salvador, and Guatemala. The construction industry is still short about 430,000 employees to fill open jobs. NUCA has urged Congress to expand the existing H-2B visa program, citing the competition for the existing 66,000 visa slots is nowhere near enough to meet the labor demands of the U.S. construction industry and those of other businesses using this program. Industry workforce and labor challenges will be a top issue at the upcoming Washington Summit. [Read more here.](#)

Women in Construction

Normally, the articles that appear here are focused on safety. This is a little bit different in that it relates more toward opportunity as well as safety. Today, women make up 46.8% of the workforce in America but only 10.9% of those women work in construction. That means that for every 10 people in construction only one is a woman. Are we missing an opportunity? One of the major advantages for women in construction is that women make 99.1% of what their male counterparts make. That's higher than any other industry. In addition, there is job opportunity. There are lots of different jobs and, progression is much higher in construction than in other industries. The unique aspect of construction is that in addition to the physical and mental exertion required, it also creates opportunity for problem solving. A natural skill that women possess. Many women have a natural instinct for operating machinery. Equipment operators are valued and hard to find. In fact, labor is hard to find. Are we exploring every opportunity? Women are coming out of the military with skills they have acquired while in service. Many of those skills can be adapted to a career in construction. Many women are looking for something different. They don't want the college education and a 9-5 job in an office someplace. They want freedom, fresh air, and a challenge to be a part of something, to create something.

This is the safety part. Any company that has women in the construction workforce recognizes that there are some issues that need to be addressed which include some of the unique safety requirements. PPE may need to be specific to the physical makeup of women. Smaller vests, smaller gloves, even smaller hard hat liners or fall arrest harnesses. Sanitary facilities or areas may need to be considered. Jobs that require more physical strength may have to be carefully assigned.

Construction is a demanding occupation. Many women are single parents and there could be child care issues, transportation concerns, work hours, pregnancies, or any number of possible roadblocks but they can be overcome with effective recruiting and screening methods. The value added is that we are faced with a shrinking workforce as it stands today. Unless we can think out of the box and take some creative steps, we will continue to struggle to find people who are even interested in doing what we do.
