The Law and Your Business

The Law and Your Business – Non-Compete and Client Lists Tony Zebouni, Esq. NUCA NF General Counsel

There was a recent appellate case out of Miami-Dade County that dealt with a non-compete-non-disclosure agreement issue. A company may have proprietary or trade secrets, and client lists that they would expect to be confidential and should take the proper steps to have personnel with access to that information sign the appropriate agreements to protect their client lists and confidential information. In addition to signing a well drafted agreements, it is important to maintain such information in a separate file marked confidential and even better to have each page stamped confidential-trade secret.

As is usually the case, ex-employees were working for a competitor and a dispute arose regarding solicitation practices. Former employees, all of whom were employed under noncompete and nondisclosure agreements, used the knowledge of their prior employers's customer lists to operate a new company that provides similar services as the former employer.

As part of the lawsuit a party requested documents containing the names of all customers that one of the parties did business with in 2020 and 2021. The opposing party objected, and the appeal ensued.

Section 90.506, Florida Statutes (2021), governs the discoverability and use of trade secrets in litigation. The statute creates an evidentiary privilege regarding trade secrets, but that privilege is not absolute. The trial court must an inquiry and require the party seeking production to show reasonable necessity for the requested materials. If production is then ordered, the court must set forth its findings.

In this case the party seeking discovery of client lists did not prevail because its attorney could not demonstrate a reasonable necessity for production. Even with comprehensive non-compete and non-disclosure agreements, it is possible for other parties to legally obtain those otherwise confidential records.

The Occupational Safety and Health Administration (OSHA) <u>announced on July 15</u> that its compliance officers will perform more than a thousand additional trench inspection nationwide to reduce the chances of jobsite fatalities. 22 people have lost their lives in trenches so far this year, an unacceptable increase that surpasses all of 2021's accident rate (15 lives lost).

SAFETY NEWS

WHY?

When I am faced with a member of our team that has a problem with compliance, I'm always curious why they choose to circumvent the regulations that are intended to promote their own safety and the safety of others. When we use the word "RULE" we are independent thinking people who are free to choose, and the word "RULE" seems to invite resistance. Guidelines, on the other hand, implies advice, recommendations, or instructions and are not expected to be the hard and fast, must do items. Rules are explicit regulations or principles governing conduct within a particular activity. Any "Pirates of the Caribbean" fans recall the negotiation with Captain Barbossa when Jack Sparrow cites the Pirate Code. A list of rules that pirates must adhere to, but Captain Barbarossa says that, "They're more what you'd call guidelines, than actual rules" which implies that there is flexibility to interpret rules as more like situational decisions that are made on the basis of convenience. "I'll obey if it fits within my area of activity as long as it's convenient." If we adopt the attitude that rules are merely guidelines rather than principles of conduct, we are compromising our own safety and the safety of others. It's a character decision. Am I making decisions based on my own idea of just what's good for me, or am I making decisions that I clearly understand as rules of conduct that are meant for me to be able to do what I love to do safely? Make good choices!


