# The Law and Your Business

## The Law and Your Business – Venue Tony Zebouni, Esq. NUCA NF General Counsel

It is important to read all the terms of a contract. A Florida contractor should favor litigating a dispute where it resides or at least where the project is being constructed. The language in a venue clause is crucial. Often when you see the word "may" as opposed to "shall", a party could consider the provision permissive not mandatory. In a recent appellate case, the issue was whether the forum selection clause contained within the parties' agreement was mandatory such that any action arising under the contract may be maintained only in the state or federal courts of Denton County, Texas, or could an action be brought in Florida. Before executing the agreement, one party modified two words in the forum selection clause. The clause, in its final form, reflected the following:

This Agreement shall be governed by and interpreted in accordance with the laws of Texas. The exclusive venues for any dispute(s) arising under this Agreement (including but not limited to breach, validity, and enforceability of the Agreement) shall may be brought in the state and federal courts for Denton County, Texas. The parties' consent to the personal jurisdiction of and venue in such courts for all of such cases and controversies, which include any action at law or in equity.

There is a critical distinction between mandatory and permissive forum selection clauses. Permissive clauses constitute nothing more than a consent to jurisdiction and venue in the named forum and do not exclude jurisdiction or venue in any other forum. In contrast, mandatory forum selection clauses provide "for a mandatory and exclusive place for future litigation.

Clauses containing language of "exclusivity" are construed as mandatory. No "magic words" are required, but the language employed must evince the parties' clear intent to limit venue. Courts have consistently construed clauses containing the word "exclusive" and its variants as mandatory. The Florida contractor was required to litigate the dispute in Texas, *ECOVIRUX*, *LLC*, *Appellant*, *v*. *BIOPLEDGE*, *LLC*

#### Infrastructure Vote Soars For Candidates In The 2022 Election

While control of the U.S. House remains to be determined at press time, one aspect stood out: "Voters made their intentions clear in the Congressional elections: they gave an enduring approval for last year's \$1.2 trillion infrastructure investment," said Doug Carlson, NUCA's Chief Executive Officer.

Carlson noted the controversy faced by several Republican lawmakers in 2021 for their summer vote to pass the core infrastructure bill. "All six of the Republicans who voted for the core infrastructure bill were re-elected, including Rep. Don Bacon of Nebraska. It was the right vote for them to make. The 2022 election results delivered a change to Congress. We'll know in the days ahead the true size and new direction of the 118th Congress. But NUCA's bipartisan approach to infrastructure legislation will help us keep a seat at the table in the new Congress. Voting to strengthen and boost American infrastructure is always a winner on Election Day," concluded Carlson.

#### DHS Releases 64K Additional H-2B Visas for 2023

The U.S. Dept. of Homeland Security announced last month that it will be issuing a regulation that will make available to employers an additional 64,716 H-2B temporary nonagricultural worker visas for FY2023, on top of the 66,000 H-2B visas that are normally available each fiscal year. These supplemental visas became available on October 1, 2022, to meet the high demand by American employers for seasonal positions. In addition to the 20,000 H-2B visas reserved for nationals of Haiti and the Northern Central American countries, the remaining 44,716 supplemental visas will be available to returning workers who received an H-2B visa, or were otherwise granted H-2B status, during one of the last three fiscal years.
